## :: Manager's Report

It is so exciting to be presenting the Manager's Report for 2024-2025 as the newly independent Lilydale Community House. Under the initiation and guidance of the CHAOS Network and with the support of the Department of Family, Fairness and Housing and Yarra Ranges Council, the House began its life at the end of 2021. Through the following two years the process of developing a Community House, bringing together people from the community to form a steering committee and putting on programs that could attract the local community to engage began.

On January 1, 2024 we became our own independent Community House with a fantastic Committee made up of local people who are passionate about community connection, reducing isolation and providing opportunities to people to come together in various activities and events.

The focus of the House is to provide a welcoming, safe and inclusive space for everyone. We do this through offering low cost and accessible activities, programs, skills learning that attract people to socially connect with others.

Over the past twelve months, we have been fortunate to have had success in filling nearly all of our activities each term. Many have been suggested by members of the community, some have been initiated by community members themselves, and we have been so glad that we have had a variety of people who have come in to offer a skill and have been willing to run classes or workshops themselves.

Our long standing Soup & Stories continues, as does Paint, Draw, Create, Explore, Singing Circle, Cooking for One, Qi Gong and our Exercise for Older Adults. We have now a number of regular programs which community members attend as well as new offerings each term particularly in craft and art.

Over the past 12 months, new workshops, information sessions, and classes have enabled a wide variety of options which have attracted a broad range of people into the Community House.

Since the beginning of 2024, we have had other offerings such as Neuro Art workshops, Mosaics, Tech Help, Learning the New which was a series of craft workshops, Guitar, Legal Advice sessions, weekly Table Tennis, Linedancing, workshops facilitated by Bunnings Lilydale, talks on Bone Health, Mental Health, History walks, Wills and Powers of Attorney, Meditation and Yin Yoga and our regular Women's Social Walk in partnership with Inspiro.

Through this time and prior to becoming independent we have also put on eight live music & dance events, created the beautiful mosaic entrance to the Community House with members of the community and produced a Soup & Stories Cookbook.

We have just completed a 12 month project named "We're Not Dead Yet", thanks to funding from the Department of Transport and Planning which has resulted in a photographic exhibition and book with interviews of 19 local people over the age of 60 highlighting their amazing lives.

During this time, we have seen many people find a space here at the Community House; a place to meet others, to feel less lonely and to forge new friendships, and for many to learn new skills.

Throughout, we have also been able to provide support to older people who are in embedded networks to claim their Energy Relief subsidy; we have provided frozen meals and bread, toiletry packs, Escapebags and food vouchers to those who need them.

We have had the opportunity to also take on placement students who are studying their Diploma in Community Services, to assist them with some experiences, as well as enriching us.

Additionally, we have auspiced a number of projects for individuals and community groups to support them to do their great work in the community, including art workshops, Chin homework groups and wildlife habitat.

We are grateful to Maureen McLaughlin, the CHAOS Network, Santha Press from Yarra Ranges Council, and Gerardine Daniels from the Department of Family, Fairness and Housing for the unwavering support to get the House up and running.

Gratitude to Nicky Condello from Mt Evelyn Community House and Reading Room who has been a great sounding board for us, and has only been too willing and generous with her advice and experience.

A huge thank you goes to Abbie Peacock who is our Admin officer, Sarah, Janice, Rob and Carole who volunteer and are only too willing to help out at a moment's notice. A big thank you also to the Lilydale Community Gardens for their ongoing maintenance of the gardens.

To the Committee of Management, thank you for your guidance, in particular our Treasurer Philip Burton who has been of massive support on so many levels.

And thank you to the community for your willingness to come to the House and engage with our programs, give us feedback so we can do better, make suggestions, and help create a warm and welcoming environment for everyone.

## :: Treasurer's Report

This is our first AGM following the end of auspice arrangements with CHAOS (Community Houses Association of the Outer-East), which concluded on 31st December 2023. Due to differing accounting periods—CHAOS operates on a calendar year (1/1 to 31/12), while we operate on a financial year (1/7 to 30/6)—this reporting period spans 18 months, from the conclusion of CHAOS management to our committee's full assumption of responsibility as of 1st January 2024.

Lilydale Community House began in September 2021 during the height of COVID-19. For the first several months, our manager could only operate via Zoom, making it an especially challenging time to launch a new organisation.

Thanks to the careful financial management of our Manager, Suyin Chan, we have built a solid financial base. As of 30th June 2025, our Balance Sheet shows equity of \$104,286, accumulated through surpluses over the past few years.

Our Profit & Loss statement for the 12 months ending 30th June 2025 shows a total surplus of \$46,994, which includes grant funding of \$33,650 received during the year. These funds are earmarked for spending in the current financial year, with one such initiative being the recently launched "We're Not Dead Yet" project. This means our operational surplus for the year, excluding earmarked grants, is \$13,344.

We gratefully acknowledge the continued support of the Department of Families, Fairness and Housing, whose funding of \$110,415, along with \$39,004 in partnership funding from Yarra Ranges Council, makes our work possible.

We also extend our thanks to the many government and private organisations whose support enables us to offer a wide range of workshops and services to the community.

A special acknowledgment must go to our Manager, Suyin Chan, whose tireless efforts in securing grants have been crucial to our success.

Attached is our Auditor's Report, which includes a recommendation to improve our documentation process by uploading invoice copies to the Xero accounting system. This has been noted and will be actioned. Our current process includes filing all invoices onsite, sending scanned copies to the Treasurer for approval prior to payment, and then providing those scans to our bookkeeper. We are committed to improving these processes.

Finally, I would like to personally thank Suyin, along with Abbie and our dedicated volunteers, for their continued hard work and passion. Thank you to our bookkeeper Emma Godaly who's help I have greatly appreciated. Their commitment is the driving force behind the success of Lilydale Community House.

#### Notes to the Financial Statements

#### For the Year ended 30 June 2025

The financial statements cover Lilydale Community House Inc. as an individual entity. Lilydale Community House Inc. is a not-for-profit Association incorporated in Vic under the

Associations Incorporation Reform Act 2012 ('the Act').

Comparatives are consistent with prior years, unless otherwise stated.

#### 1. Basis of Preparation

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs.

These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

#### 2. Summary of Significant Accounting Policies

#### (a) Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short term investments which are readily convertible to known amounts of cash, and which are subject to an insignificant risk of change in value.

#### (b) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

(c) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(d) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment of losses.

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

(e) Revenue and Other Income

Sale of Goods

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest Revenue

Interest is recognised using the effective interest method.

Rendering of Services

Revenue in relation to rendering of services is recognised depending on whether the outcome of the services can be estimated reliably. If the outcome can be estimated reliably then the stage of completion of the services is used to determine the appropriate level of revenue to be recognised in the period.

If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.

Subscriptions

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

Other Revenue

Other revenue is recognised when the association is entitled to the funds.
